## 'Soul contractees' beware

A soul contract is an agreement we enter into for the purpose of learning and spiritual development, at least in theory.

These contracts reveal themselves when you start noticing the same relationship patterns over and over in your life, or when you experience a very intense relationship with someone, whether positive or negative.

The two types of soul contracts are: 1) past life contracts or vows; or 2) in-between life contracts or vows.

I am also actually aware of a rare third kind of soul contract: one which is made to a parent or loved one in one's current life, under a great deal of love, daily stress, hardship, and the greatest sense of obligation, devotion, and responsibility, and the contract is later confirmed to be accepted — as if signed by the two parties — by the same parent or loved one already inbetween lives, after he or she passed away.

Past life contracts or vows are unconscious, often the result of trauma or negative experiences. Rarely past life contracts can be the result of vows consciously taken with great love, and/or devotion, and even made verbally in a conscious or obvious manner, such as the commitments or vows Jesus took towards his disciples, which are fairly obvious from a non-superficial reading of the Gospels (John 14:1–3).

In-between life contracts or vows, on the other hand, are much more intentional agreements, but they probably happen outside of the commitments or vows to love, or alternatively, to be loyal to a religion or specific religious tradition, since they involve people who are closer in age to each other.

In-between life contracts or vows are always about healing and spiritual evolution, so unlike most past life contracts or vows, they are helpful and purposeful. They are closely related to our life mission and soul purpose. For example, in very advanced, probably unprecedented spiritual research, among 14 of my previous incarnations, I was able to identify not one, but four distinct life missions.

However, in-between life contracts or vows are always challenging, just as even the most positive learning experiences in a school or university can still be quite challenging.

It should be noted that revoking a contract creates an empty space or vacuum, so it is important, if you intend to revoke a particular contract, to consciously make the apparently opposite commitment or vow with regard to a specific person, or towards a specific family or clan.

Example: if you apparently vowed a healthy, empowering, and fulfilling relationship with someone, you can revoke that contract simply by making a vow to isolate yourself from, or totally alienate the person who, causes only social or emotional turmoil or harm, and little or no social or emotional growth.

Please understand that because of a multi-decade ectohistory of social or emotional turmoil or harm, and little or no social or emotional growth, all soul contracts that Kaisiris Tallini, aka Cesidio Tallini, has apparently made in previous lifetimes, and even in-between previous lifetimes, are to be considered null and void.

Yes, if you are intelligent enough to understand it, 'Judgement Day' has already begun in private, and I have every reason to believe that a full 'Judgement Day' will soon be made manifest in a very official, and/or public manner.
